There was additional discussion regarding the Music City Center procurement log and the minority, small, women, and local business participation for Omni.


With no additional business a motion was made to adjourn, with no objection the Construction & Development committee of the CCA adjourned at 12:40 p.m.

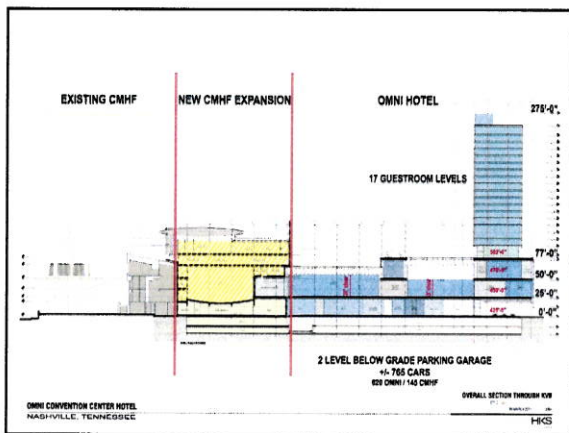
