

**MINUTES OF THE CONSTRUCTION & DEVELOPMENT
COMMITTEE MEETING OF THE

The Construction & Development Committee of the Convention Center Authority of the Metropolitan Government of Nashville and Davidson County (CCA) met on July 21, 2011 at 8:07 a.m., at the MCC Project Offices, Nashville, Tennessee.

Charles Robert Bone was asked to begin the discussion and he noted that the purpose of the meeting was to review the most recent version of the Omni design plans based on the 50% design drawings dated May 27, 2011.

There was also discussion and updates on the condemnation litigation and the KVB project. Mr. Atema noted the latest DBE numbers were submitted to the State yesterday.

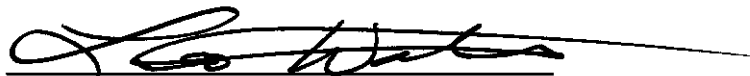
With no additional business a motion was made to adjourn, with no objection the Construction & Development committee of the CCA adjourned at 9:24 a.m.
